Team A scores a goal then team A takes a penalty. Where does the next face-off go? (HC Rule 4.13b)	Correct		
O a) In team A's end

Od) at the face-off dot outside of team B's end			
True or False, the face-off will take place at center ice ONLY if the officials have incorrectly called an icing against a team who is shorthanded.	Correct		
True, all other cases of errors on icing cannot be corrected once the play is stopped.			

False, any referee error related to icing being called incorrectly can result in a face-off at center ice. The referee stops play when the A-Team goaltender covers up the puck. There is gathering of players and B11 (who was near the blue line) comes in to the gathering. B6 (who Correct was also at the blue line when the play was stopped) stays at the blue line. Where does the next face-off go? (Rule 10.2k) a) In team A's end b) it stays in team A's end because only one of the B players from the blue line came into the gathering. If both B-players come in then the faceoff would go outside of Team A's end. Oc) it takes place in team B's end because at least one player came in from the blue line. d) it takes place at one of the the neutral zone dots near team A's end Team A has been ejected from the same face-off twice at the same stoppage. What should the Correct referee do? The captain may talk to the referee if she is polite.	
The captain may talk to the referee if the penalty does not include removal from the game.	
• The captain may not talk to the referee from the moment the penalty is assessed to the expiration of the penalty.	<b>✓</b>
A defensive player (not the goalie) is in the crease, and the puck is outside the crease. The player holds or grabs the puck, pulling the puck into her body that is in the crease. The play is stopped. State Official's decision. (Situation 1 Rule 10.3(c))	Correct
O Conduct faceoff at one of the end zone dots.	
O Award a penalty shot as the puck was covered in the crease.	
• Assess a minor penalty as the puck was initially grabbed outside the crease.	✓
Assess a minor penalty. However, if this occurs in the final two minutes (or overtime) then award a penalty shot.	
A player skates backwards over the blue line with the puck; that player's skates clearly enter the zone before the puck does. Is the player offside? (Rule 10.8a Note 2)	Correct
The player is not offside as he had possession and control of the puck.	✓
The player is offside as the skates entered the zone prior to the puck.	
In which zones is a penalty shot assessed for throwing a stick at the puck carrier? (Rule 9.8a)	Correct
If the stick thrower is in his or her defensive zone. The puck carrier (and puck) is some where else on the ice.	
Assess a penalty shot at any time that a stick is thrown at the puck carrier regardless of zone.	
If the puck carrier (and the puck)is in the neutral or defending zone of the stick thrower.	
If the puck carrier (and the puck) is in the defending zone of the stick thrower.	✓
A goalie catches a puck then proceeds to drop kick the puck to a team mate in the neutral zone. What penalty(s) may be assessed, if any at all. (Rule 4.11f)	Correct
• Assess a Major and GM if an injury occurs to a player on the other team; A minor if no injury occurs.	<b>✓</b> 2021-02-10.

Assess a Major and GM if an injury occurs to a player on the other team; no penalty if no injury.	
Assess a minor penalty if this occurs outside the goaltender's crease. If the goaltender is in the crease then no penalty and play continues.	
This is legal. No penalty ever.	
The goaltender is on the ice, but away from his goal crease. A player from the opposing team takes possession and control of the puck and shoots it towards the open goal. As the puck is about to enter the open goal a defending player knocks the goal of its mooring(s). Do you award a goal? (Situation 6 Rule 4.10c)	Correct
Yes, the goalie was not in the net.	
No, the goalie is still on the ice.	✓
No, a goal is only awarded if a stick was thrown by the defending team.	
A player on a breakaway in the neutral or attacking zone is fouled from behind and the referee signals a penalty shot. Before the play is completed a second infraction is signaled against the same team, whether it be to the same player or a different player. The penalty shot is assessed for the first infraction (i.e. the foul from behind). Is the penalty for the second infraction still assessed? (Situation 14 Rule 4.9)	Correct
Yes, if there is no goal scored on the penalty shot.	
Yes. The second penalty is always assessed.	✓
No. The second penalty is not assessed because it happened after the penalty shot infraction.	
State Official's decision. Team A changes the goalies during the play. (Situation 4 Rule 2.5b)	Correct
Stop play immediately and assess an ineligible player penalty to the goalie coming off the bench.	
Assess a delayed penalty for ineligible player.	
Do not stop play, do not assess a penalty. This is fine so long as all rules governing line changes are followed.	<b>✓</b>
Stop player under illegal substitution, make the goalies switch back and complete a face-off in the offending team's zone.
